**Paul Schoukens** is Professor of Social Security Law at the KU Leuven (Belgium) and at Tilburg University (the Netherlands), where he holds the Instituut Gak chair International and European Social Security Law. He is Secretary-General of the European Institute of Social Security, an international scientific network of persons professionally active in the fields of social security and social protection, and is program director of the specialized Master European Social Security. His research topics of interest are the social protection of self-employed persons and atypical workers, healthcare systems, and the relationship between e-technology and social security administration.

**Frederic De Wispelaere** is working as a research expert at HIVA and the Research Group Social and Economic Policy and Social Inclusion at the KU Leuven, focusing among others on the following research topics: social fraud and undeclared work, intra-European labor mobility - in

particular intra-EU posting, EU coordination of social security systems. He is currently active within the Network Statistics FMSSFE, set up by the European Commission, DG Employment, Social Affairs and Inclusion. This network of experts collects statistics on intra-European free movement of persons, European coordination of social security and curbing fraud and error.

**Martina Axmin**, is a senior lecturer at the Faculty of Law of Lund University. She conducts research within the fields of EU law, social security law and health law. Currently she is involved in a project on prolonged Working Lives, Older Workers and Dismissals. She is also Swedish national expert in the European Commission's MoveS network (Free Movement of Workers and Social Security Coordination).

**Niel Laenen** is a doctoral researcher affiliated with the Institute for Social Law (KU Leuven, Belgium). After obtaining a master's degree in law in June 2019 (KU Leuven, Erasmus exchange Uppsala Universitet), he began his doctoral research on intrastate social security coordination of decentralized social security schemes (and its links with EU law) as of October 2019. His main research interests include social security law, European Union law and constitutional law. Furthermore, he is also involved in teaching activities as a teaching assistant to prof. dr. Paul Schoukens and prof. dr. Danny Pieters. In this capacity, he lectures on legal methodology and supervises students writing papers and dissertations within the broad field of social security law.
